FISCAL IMPACT:

There is no new net County cost associated with the recommended action. Staff costs associated with enforcement and administration of Fresno County Ordinance Code section 10.60.060 — Medical Marijuana Cultivation Regulations is being absorbed within the Sheriff's Org 3111 Adopted Budget. DISCUSSION:

On March 24, 2015, staff from the Fresno County Sheriff's Office ("staff") investigated a possible marijuana grow located on the property at 9265 ½ S. Grantland, Fresno, CA 93652, APN 035-360-33S (the "Property"). With respect to the Appellants, staff confirmed that each of them were growing 79 (a total of 158) marijuana plants on the Property in an enclosed structure (sometimes referred to as a "grow house") and eradicated them.

Both Appellants were present at the Property when staff arrived, and were each cited by staff at that time. Mr. Saysamongdy advised staff that he rented the property for \$900.00 per month during the growing season. Staff did not identify the person(s) responsible for renting the property to the Appellants.

The stated basis for the appeals filed by the Appellants is that they are unable to pay the fine amounts.

In addition to the marijuana plants cultivated by Appellants, staff identified two additional grow houses, the first containing 125 marijuana plants, and the second 156 marijuana plants. Mr. Saysamongdy said that these other plants were being cultivated by two individuals by the names of "Aye" and "Syscsai". These individuals fled the Property when staff arrived to investigate the grow.

APPLICABLE LAWS:

Fresno County Ordinance Code chapter 10.64 provides that administrative penalties can be imposed for each and every marijuana plant cultivated in violation of Chapter 10.60 in the amount of one thousand dollars (\$1,000) per plant.

Pursuant to Fresno County Ordinance Code chapter 10.64.070.B, your Board shall only consider evidence that is relevant to whether the violations occurred, and whether the recipients of the citations are 'responsible parties' as defined by Fresno County Ordinance Code chapter 10.64.030.D ["any other entity whatsoever whose action or actions caused or contributed to violations of codes].

The decision of your Board shall be final upon adoption of an order containing its determination. The administrative penalties, if any, are due and payable immediately upon the adoption of an order denying the appeal.

Narrative

ASSITING PERSONELL:

SOURCE: On 03/25/15, at about 1523 hours Fresno County Sheriff's Detectives self-initiated a Marijuana compliance check at 9265 1/2 S. Grantland Avenue, Fresno. We were in full, marked Sheriff's Department uniform and in a marked, Sheriff's Department vehicle. We arrived on scene at about the above mentioned time and contacted Bouathong Saysamongoy (Involved Party).

VICTIM STATMENT: None.

WITNESS STATEMENT: None.

INVESTIGATION: The 9265 1/2 S. Grantland address is located on Grantland just south of Manning, just west of the town Raisin City. It is located on the west side of Grantland and down a dirt road about 200 yards west of Grantland. It is a single story residence with a chain link fence surrounding the property. There was a large, 10' solid wooden fence surrounding the back yard of the residence. I was familiar with the property due to the fact the previous year Fresno County Sheriff's Office Narcotics Unit had a similar complaint of people growing Marijuana at this residence. At that time, 9/16/14, when I arrived on scene to investigate several people ran from the residence and I located a large Marijuana cultivation operation. I notified the people growing the Marijuana of the county ordinance and had a letter sent to the property owner of the ordinance.

On 3/25/15, when we arrived at the location we had to jump over a small chain link gate to gain access to the property. This was the only access point where we could make contact with someone at the front door. The gate was about 50 yards north / east of the front door. As we approached the front of the residence, we got about half way up the driveway when two large dogs began barking at us. That is when Bouathong opened a gate, from the backyard, located on the east side of the residence. As Bouathong opened the gate we saw two people running from the location to the back fence and jump over it. The subjects continued running south bound through an open field and into an almond orchard. While Bouathong had the gate open I saw a large hot house with Marijuana growing inside of it. I saw the Marijuana plants were about 1' to 3' in height. After Bouathong had secured the dogs in the front yard, he escorted us to the backyard to show us the Marijuana plants.

Bouathong explained to us that he and his wife, Kaysone Saysamongoy (Involved Party), were growing Marijuana on the property. Bouathong continued by saying this was the second year that he has grown Marijuana at this property. He stated that he and his wife have 160 plants, 80 plants each, in one of the hot houses located in the back yard. Bouathong said there were four people total growing Marijuana on the property. Bouathong stated he only knows the other two subjects "Aye" and "Syscsai". Bouathong said "Aye" and "Syscsai" were at the location with him when we arrived, but he does not know why they ran. Bouathong said the other two hot houses on the property belonged to "Aye" and "Syscsai". He did not know how many plants they were growing in their hot houses. Bouathong continued by saying that he rents the property from a Maria but does not know her last name. He says he paid her \$900.00 to rent the property for the growing season. Bouathong showed us his and Kaysone's medical Marijuana cards. We asked Bouathong how he uses his Marijuana which he stated boils it, cooks and showers with it. He refused to tell us how much he uses each time he does use his Marijuana. However I asked Bouathong if he remembered me being there the year before and telling them not to be growing Marijuana at the residence. Bouathong stated he did remember me being out there, but did not answer about growing Marijuana again at the location. Bouathong said no one lives at the residence but they only grow there.

I was familiar with the property due to the fact the previous year Fresno County Sheriff's Office Narcotics Unit had a similar complaint of people growing Marijuana at this residence. At that time, 9/16/14, when I arrived on scene to investigate several people ran from the residence and I located a large Marijuana cultivation operation. I notified the people growing the Marijuana of the county ordinance and had a letter sent to the property owner of the ordinance.

On 3/25/15, when we arrived at the location we had to jump over a small chain link gate to gain access to the property. This was the only access point where we could make contact with someone at the front door. The gate was about 50 yards north / east of the front door. As we approached the front of the residence, we got about half way up the driveway when two large dogs began barking at us. That is when Bouathong opened a gate, from the backyard, located on the east side of the residence. As Bouathong opened the gate we saw two people running from the location to the back fence and jump over it. The subjects continued running south bound through an open field and into an almond orchard. While Bouathong had the gate open I saw a large hot house with Marijuana growing inside of it. I saw the Marijuana plants were about 1' to 3' in height. After Bouathong had secured the dogs in the front yard, he escorted us to the backyard to show us the Marijuana plants.

Bouathong explained to us that he and his wife, Kaysone Saysamongoy (Involved Party), were growing Marijuana on the property. Bouathong continued by saying this was the second year that he has grown Marijuana at this property. He stated that he and his wife have 160 plants, 80 plants each, in one of the hot houses located in the back yard. Bouathong said there were four people total growing Marijuana on the property.
