WHEREAS, the County of Fresno has received \$210,000 from insurance reimbursement (\$34,441) and from the sale of surplus vehicles (\$175,559); and

WHEREAS, Sheriff-Coroner has \$70,000 in unclaimed property funds available for vehicle replacement in the Sheriff Fund 2225, Subclass 33250; and

WHEREAS, said monies are not included in the FY 2016-17 appropriations and estimated revenues of the Sheriff-Coroner Organization 3111; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2016-17 Sheriff-Coroner Organization 3111 as follows:
