Resolution

WHEREAS, the County of Fresno, County Clerk-Registrar of Voters Department has incurred additional costs related to special elections, ballot measures, and increases in salary and benefit costs; and

WHEREAS, the County Clerk- Registrar of Voters Department requires an additional \$839,989 in appropriations to pay for those costs; and

WHEREAS, \$839,989 of Unassigned Fund Balance is available in General Fund 0001, Subclass 10000 to fund these expenditures; and

WHEREAS, said monies are not included in the FY 2023-24 adopted appropriations and estimated revenues of the County Clerk-Registrar of Voters Org 2850; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;


NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2023-24 County Clerk-Registrar of Voters Org 2850 as follows:


