IN THE AMOUNT OF \$600,000)

WHEREAS, the County of Fresno, Facility Services, Organization (Org) 8935, requires an increase in appropriations in the amount of \$600,000 to allow for the payment of roofing maintenance services to County buildings necessary to meet departmental demands and use; and

WHEREAS, said additional costs will be financed by revenue from user County Departments benefiting from said services in the amount of \$600,000; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues of the FY 2018-19 Facility Services, Org 8935; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5ths vote by the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in FY 2018-19 Facility Services, Org 8935 as follows:

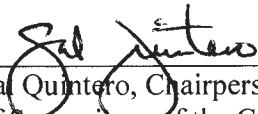
