WHEREAS, County Service Area 34 Zone F (CSA 34F) also known as The Vistas, was formed on October 8, 2019 to provide various utility services to the community; and

WHEREAS, \$12,288 is available in the fund balance of the CSA 34F Fund 0830 to fund the added operational costs; and

WHEREAS, said monies are not included in the adopted appropriations of the FY 2019-20 Budget for CSA 34F, Org 9324; and

WHEREAS, Section 29130 of the Governmental Code provides for the appropriations of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer –Tax Collector is authorized to increase the appropriations in the FY 2019-20 appropriations in the CSA 34F, Org 9324 as follows:




