**WHEREAS**, the County of Fresno, County Clerk-Elections Department has incurred additional costs related to special elections; and

**WHEREAS**, the Elections Fees Fund 0050, Org 1080, Subclass 17150, has sufficient funding for an Operating Transfer-In to the County Clerk-Registrar of Voters Org 2850 that may be used to fund these costs; and

**WHEREAS**, said monies are not included in the FY 2023-24 adopted appropriations of the Election Fees Fund 0050 Org 1080; and

**WHEREAS**, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

**NOW THEREFORE, IT IS ORDERED** that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2023-24 Election Fees Fund 0050 Org 1080 as follows:


