The National Latino Behavioral Health Association (NLBHA) will provide Behavioral Health Interpreter Training for Interpreters/BHIT for Providers to staff in DBH's system of care. Four BHIT for Interpreters trainings (14 hours of instruction each) will take place over the course of this agreement with a capacity of 35 attendees per session. DBH is targeting one BHIT for Interpreters training each quarter.
