This company is used for DNA testing associated with criminal cases for the Fresno County Sheriff's Office. They are used for grant and overflow casework within the Sheriff's Office Forensic Laboratory.

They are compatible with our DNA systems as they use the same DNA platform as the Sheriff's Office DNA lab; we have inspected their facility and Quality Assurance audits have found them acceptable to handle Sheriff's Office casework. At this time SERI will be moving to the Globalfilier DNA system by Jan 2017 which will match what we are doing within our lab. This will be required for any vendor that we use. We have a long track record with SERI as they are the leading private lab in the state for DNA analysis.

- This company mainly handles our out-sourced DNA casework that is associated with the Federal DNA grants accepted and approved by the Board of Supervisors(BOS) for the last several years (2014, 2015) and currently awaiting the award for 2016. The grants that have been approved by the BOS and the grant committee state that this company will be used in association with the DNA testing within these grants. They are a fully accredited Laboratory which is required by the grant and by our accreditation standard. It is also vital that we have a facility in California, as occasionally we must hand deliver evidence to them for testing and they are located in Richmond, CA which is a short drive from Fresno. We are currently using their services and have had a relationship with them for many years that has been very suscessful. SERI has always strived to provide us the best service often at no extra cost. The FBI is requiring us to move to a new DNA system called Globalfilier by Jan 2017, SERI has committed to bring this system on-line as well to continue our partnership. Specifically, they are the oldest vendor in Califonia that provides this service and they are one of the labs that were approved by the NIJ grant committee to perform DNA casework associated with Sheriff's Office cases.
