SUMMARY OF PROPOSED ORDINANCE

The Ordinance would amend the Fresno County Ordinance Code Chapter 4.08, Uniform Public Construction Cost Accounting Act, to update the allowable dollar amount limitations for negotiated contracts, informally bid contracts and force account work for construction of public projects, to those currently or subsequently allowable under the applicable and corresponding provisions of the Public Contract Code.
