

1 Lighting Act of 1972 to levy and collect in the Tenaya Park Assessment District, for CSA 2, an assessment
2 of the total cost of the maintenance and operation expenses of Tenaya Park for the 2021-22 fiscal year.

3 **Section 3.** In connection with the proceedings that are the subject of this resolution, the Board
4 hereby appoints and designates Steven E. White, P.E., Director, Department of Public Works and
5 Planning, County of Fresno, registered under the Professional Engineers Act (Division 3, Chapter 7 of
6 the California Business and Professions Code, beginning with Section 6700), as the Assessment
7 Engineer (Assessment Engineer).
8

9 **Section 4.** The Assessment Engineer is hereby ordered to prepare and, no later than July 13,
10 2021, file with the Clerk of the Board a written report (Engineer’s Report) with regard to an assessment
11 of the total cost of maintenance for Tenaya Park for the 2021-22 fiscal year. The Engineer’s Report shall
12 comply with the requirements of Streets and Highways Code, Division 15, Part 2, Chapter 1, Article 4,
13 beginning with section 22565, and Section 4 of Article XIII D of the California Constitution.

14 **Section 5.** The Board hereby finds and determines that it took all of the foregoing actions and
15 made all of the foregoing findings in full compliance with the law, including, without limitation, the
16 Landscape and Lighting Act of 1972, Article XIID of the California Constitution, and any other law referred
17 to in this resolution. All proceedings referred to in this Resolution have been taken with respect to CSA
18 2.

20 **Section 6.** This Resolution shall take effect immediately upon its adoption.

21 **Section 7.** The Clerk of the Board shall certify to the adoption of this Resolution and shall
22 cause a certified copy of this Resolution to be filed in the office of the Clerk.
