The providers on this Master Agreement are required to be licenced through the Community Care Licensing (CCL) division of California Department of Social Services and are required to provide services in accordance with California Welfare and institiuions Code, section 5801. Fresno County DBH contracts with all local licensed residenital care facility providers in the County that meet this criteria and are seeking a contractual agreement.
5. Identify from Administrative Policy #34 what circumstances constitute a Suspension of Competition.
 - In an emergency when goods or services are immediately necessary for the preservation of the public health, welfare, or safety, or for the protection of County property.
 - When the contract is with a federal, state, or local governmental agency.
 - When the department head, with the concurrence of the Purchasing Agent, finds that the cost of preparing and administering a competitive bidding process in a particular case will equal or exceed the estimated contract amount or \$5,000 whichever is more.
 - When a contract provides only for payment of per diem and travel expenses and there is to be no payment for services rendered.
 - When obtaining the services of expert witnesses for litigation or special counsel to assist the County.
 - When in unusual or extraordinary circumstances, the Board of Supervisors or the Purchasing Agent/Purchasing Manager determines that the best interests of the County would be served by not securing competitive bids or issuing a request for proposal.
6. Explain why the unique qualities and/or capabilities described above are essential to your department.
This Master Agreement will allow DBH to continue to place conserved persons served locally and appropriately with experienced providers to keep them closer to their families while reducing the costs associated with unnecessary higher levels of care. It is essential that DBH maintains an adequate network of providers/beds to ensure placement of these persons served locally in licensed Board and Care facilities.
