WHEREAS, Probation Org 34409999 requires \$125,000 to meet expenditures for the additional services required from Fresno County Superintendents of Schools for Senate Bill 823 requirements; and

WHEREAS, \$125,000 is available in the fund balance of the DJJ Realignment Fund 0075, Subclass 17305, Org 1145 to fund these expenditures; and

WHEREAS, said monies are not included in the adopted appropriations and revenues of Probation Org 34409999; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors.

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2024-25 Probation Org 34409999 as follows:
