WHEREAS, the County of Fresno will receive \$144,038 from the Bureau of Justice Assistance, Department of Justice (DOJ) to reduce DNA casework backlog; and

WHEREAS, \$144,038 is not included in the adopted appropriations and estimated revenues of the Sheriff-Coroner-Public Administrator's ORG 3111 for Fiscal Year 2022-23; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector be authorized to increase the Fiscal Year 2022-23 appropriations for the Sheriff-Coroner-Public Administrator's ORG 3111 as follows:
