

IN THE MATTER OF ADOPTING THE BUDGET  
(INCLUDING CAPITAL PROJECTS BUDGETS) FOR THE  
COUNTY OF FRESNO FOR THE PERIOD BETWEEN JULY  
1, 2025 AND THE BOARD OF SUPERVISORS' ADOPTION  
OF THE FISCAL YEAR 2025-26 FINAL RECOMMENDED  
BUDGET

**WHEREAS**, the Recommended Budget (including Capital Projects budgets) of the County of Fresno, State of California (the “County”), for the period between July 1, 2025 and the Board of Supervisors’ adoption of the Fiscal Year (FY) 2025-26 Final Recommended Budget has been prepared, made available for public distribution, and distributed according to law; and

**WHEREAS**, notice that the Recommended Budget (including Capital Projects budgets) of the County for the period between July 1, 2025 and the Board of Supervisors' adoption of the FY 2025-26 Final Recommended Budget has been so prepared and made available for public distribution, specifying the time and place of the Board of Supervisor's hearing, has been published on June 11, 2025, in *The Business Journal*, a newspaper of general circulation, for the time in the manner required by law; and

**WHEREAS**, a hearing upon the Recommended Budget (including Capital Projects budgets) of the County for the period between July 1, 2025 and the Board of Supervisors' adoption of the FY 2025-26 Final Recommended Budget was held by the Board of Supervisors as described in the published notice of hearing, at which hearing items of such Recommended Budget were considered and discussed and all additions and deletions to such Recommended Budget were made; and

**WHEREAS**, before taking action under this Resolution, members of the public were given the opportunity to appear at the public budget hearing of the Board of Supervisors and be heard

1 regarding any item in the Recommended Budget (including Capital Projects budgets) of the  
2 County for the period between July 1, 2025, and the Board of Supervisors' adoption of the FY  
3 2025-26 Final Recommended Budget or for the inclusion of additional items.

4 **WHEREAS**, the Recommended Budget (including Capital Projects budgets) of the County  
5 for the period between July 1, 2025, and the Board of Supervisors' adoption of the FY 2025-26  
6 Final Recommended Budget, as adjusted by the Board of Supervisors at the conclusion of the  
7 public budget hearing, contains the specific requirements of Government Code section 29089.

8 **NOW, THEREFORE, BE IT RESOLVED**, that the Recommended Budget (including Capital  
9 Projects budgets) of the County for the period between July 1, 2025 and the Board of  
10 Supervisors' adoption of the FY 2025-26 Final Recommended Budget, as amended during the  
11 Board of Supervisors' public budget hearing, be and is hereby adopted as the Budget (including  
12 Capital Projects budgets) of the County for the period between July 1, 2025 and the Board of  
13 Supervisors' adoption of the FY 2025-26 Final Recommended Budget for all funds governed by  
14 the Board of Supervisors, which document is adopted by reference, as provided for the  
15 Government Code Section 29090, and made a part of this Resolution.
