The Proposed Ordinance will amend the Fresno County Master Schedule of Fees, Charges and Recovered Costs, by amending Section 1800, Probation, Subsection 1815, Daily Rate, which sets the fee charged to recover costs for the County of Fresno to house youth from other counties at the Juvenile Justice Campus.
