WHEREAS, the Fresno County Probation Department has made a significant contribution to the citizens of Fresno County for the last 110 years. Probation is an essential part of the criminal justice system and provides many offenders with a pathway to successful, lawful living; and

WHEREAS, on any given day, the Fresno County Probation Department supervises approximately 13,000 adult and juvenile offenders. Annually, the department completes in excess of 30,000 reports, screenings, and assessments; this includes adult pre-sentencing and juvenile dispositional reports, violation of probation, pretrial, warrant and probation modification reports to the Fresno County Superior Court. The professionals employed in this field faithfully supervise individuals on probation and recognize the public's supreme right to be safeguarded from criminal activity; and

WHEREAS, the Probation Department embodies this year's motto, "Restoring Trust, Creating Hope" through partnerships with other law enforcement agencies and community-based organizations to provide public safety services to our local neighborhoods, as well as providing offenders with rehabilitative programs and referrals for various needed services; and

WHEREAS, Probation staff endorse prevention, intervention, advocacy, and offender accountability, and performs crucial duties that support and protect victims of crime; and

WHEREAS, Pretrial, Probation, and Parole Supervision Week is a time to recognize and honor the dedication and professionalism exhibited by Probation Department staff who strive to make our neighborhoods a safer place to live and raise families.

NOW THEREFORE, BE IT RESOLVED that the Fresno County Board of Supervisors hereby proclaims July 18 through July 24, 2021, as Pretrial, Probation, and Parole Supervision Week in the County of Fresno.


