WHEREAS, the Sheriff-Coroner Organization (Org) 3111 will receive \$428,510 for overtime and to purchase much needed Forensic training and equipment from the California Governor's Office of Emergency Services (Cal OES) Internet Crimes Against Children (ICAC) program; and

WHEREAS, said monies are not included in the FY 2018-19 appropriations and estimated revenues of the Sheriff Organization 31116310; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2018-19 Sheriff Organization 31116310 as follows:
