WHEREAS, the County of Fresno will receive \$120,000 as an Operating Transfer In from the Sheriff Special Revenue Fund 0095, HIDTA State Forfeiture Special Revenue Fund Org 1464; and

WHEREAS, said monies were not included in the FY 2020-21 adopted appropriations and estimated revenues of the Sheriff-Coroner-Public Administrator Organization 3111; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2020-21 Sheriff-Coroner-Public Administrator Organization 3111 as follows:


