WHEREAS, the County of Fresno Sheriff-Coroner Org 3111 will receive \$348,250 as Operating Transfers In from the Inmate Welfare Fund's Special Revenue Fund, 0096, Inmate Welfare Fund Org 1500 to purchase a turnkey software/hardware tablet system to support the inmates' educational, vocational, religious, health and wellness and cognitive behavioral needs; and

WHEREAS, said monies are not included in the FY 2018-19 adopted appropriations and estimated revenues of the Sheriff-Coroner Organization 31114008; and

WHEREAS, Section 29130 of the Government Code provides for the appropriations of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2017-18 Sheriff-Coroner Organization 31114008 as follows:

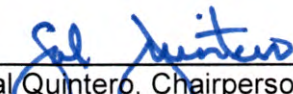

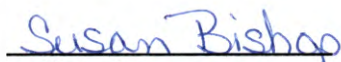
