NOTICE is hereby given that at its regularly scheduled meeting on April 13, 2021, the Fresno County Board of Supervisors adopted Ordinance No. 21-005, an Ordinance of the County of Fresno, State of California.

SUMMARY OF ORDINANCE

The ordinance adopted by the Board of Supervisors repeals Ordinances Nos. R-450-3751 and T-805-363, previously adopted by the Board of Supervisors on

February 1, 2011.

Ordinance R-450-3571, which is to be repealed by the proposed ordinance, pertained to the Friant Ranch Community Plan area, and rezoned the 7.19-acre "Depot Parcel" from Single-Family Residential Agricultural District (R-A) to General Commercial (C-6), rezoned two parcels totaling 6.6 acres from R-A and C-6 to Open Space (OS), and rezoned a 106-acre parcel from AE-20 (Exclusive Agricultural, 20-acre minimum parcel size) Zone District to OS, as described in Amendment Application No. 3751. Ordinance T-805-363, which is to be repealed by the proposed ordinance, adopted the Friant Ranch Zoning Regulations, found at section 840.B through 840.B(h) of the Fresno County Zoning Ordinance, which include specific zoning districts for the Friant Ranch Specific Plan Area, as described in Amendment to Text Application No.

As stipulated by a Writ of Manda of February 16, 2021 by the Fresn County Superior Court, this Ordinance designated as Ordinance No. 21-00 ("Repealing Ordinance"), repea Ordinance Nos. R-450-3751 an T-805-363, which would cause the designation of the Subject Parcels to revert to their original designations in the Zoning Ordinance. Ordinance No 21-005 shall take effect thirty days after its passage.
