WHEREAS, the County of Fresno, Sheriff’s Office has American Rescue Plan Act costs of \$2,479,551; and

WHEREAS, the Auditor-Controller/Treasurer-Tax Collector (ACTTC) Department requires an additional \$2,479,551 in appropriations to pay for those costs; and

WHEREAS, \$2,479,551 is available in the fund balance of the ACTTC – Disaster Claiming Fund 0026, Subclass 91021 to fund these expenditures; and

WHEREAS, said monies are not included in the FY 2022-23 adopted appropriations and estimated revenues of the American Rescue Plan Act Org 1033; and


WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2022-23 American Rescue Plan Act Org 1033 as follows:
