RESOLUTION

WHEREAS, the Sheriff-Coroner Org 3111 will receive \$142,653 plus accrued interest as an Operating Transfer In from the Indian Gaming Special Distribution Fund (SDF), IGSDF District Attorney Subclass 10021 for the law enforcement services;

WHEREAS, said monies were not included in the adopted appropriations for the FY 2021-22 appropriations and estimated revenues of the Sheriff Org 3111; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer –Tax Collector is authorized to increase the appropriations in the FY 2021-22 Sheriff Org 3111 as follows:


