WHEREAS, the Department of Public Health Organization 5620 will receive \$285,332 as an Operating Transfer In from the Special Revenue Fund 0080, Subclass 17351, Contingency Fines & Penalties Fund Org 1151; and

WHEREAS, said monies are not included in the FY 2015-16 adopted appropriations and estimated revenues of the Department of Public Health Org 5620; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2015-16 Department of Public Health Org 5620 as follows:






