  - The County will not purchase the requested item directly from the vendor. This item is specified by make and model number in the construction plans and specifications for a public works project. Procurement and installation will be performed by the lowest responsible bidder awarded the project by the Board of Supervisors. The contractor will purchase the equipment and install it as a part of the construction contract. It is anticipated that the cost to the contractor will be approximately \$20,000 each for fourteen (14) fixtures, or approximately \$280,000 total. The exact cost of equipment will not be known as it will be included in the contractor's bid.

In the event the fixtures are damaged, the need to be replaced is imperative for the County of Fresno Detention Facility to continue operation, and it is impractical for the Fresno County Detention Facility to keep bulk replacement parts for multiple fixture models due to limited storage capacity.

Acorn Secur-Care Ligature Resistant LR1449 Combination Fixture provides the function of a lavatory, drinking fountain and water closet within a Housing Cell. The County of Fresno Detention Facility contains Detention Pods equipped with these exact Acorn Combination Fixtures. In the event the fixtures are damaged, immediate repair is imperative for the County of Fresno Detention Facility to continue operation. The use of salvaged parts and parts on hand is critical to make those immediate repairs and it is impractical for the Fresno County Detention Facility to keep bulk replacement parts for multiple fixture models due to limited storage capacity.
