Certification to CFD Administrator of All Parcels Subject to Special Tax Levy in Mello-Roos Community Facilities District

I, Steve E. White, Director, Department of Public Works and Planning, certify as follows:

1. I give this certificate with respect to Community Facilities District No. 2006-01 (Police Protection Services) of the County of Fresno (District).
2. I have reviewed and am familiar with the Special Tax Rate and Method of Apportionment (RMA) that is applicable to the District, which is on file with the Sheriff-Coroner's Business Office (2200 Fresno Street, Fresno, California 93717). Each of the capitalized terms in this certificate that is not defined in this certificate has the meaning given to it in each applicable RMA.
3. I understand and intend that the CFD Administrator, namely the Fresno County Sheriff-Coroner, will rely on this certificate to prepare the list of properties that are subject to the levy of the Special Tax for County Fiscal Year 2017-18, as provided in each applicable RMA.
4. I understand and acknowledge that the CFD Administrator will certify that list of properties to the Fresno County Board of Supervisors for levy of the Special Tax on each listed property for County Fiscal Year 2017-18, in the amount provided in the applicable RMA.
5. I have made a careful and diligent review of Department of Public Works and Planning records with respect to all parcels located within the Districts. Based on that review, I have determined that, as of May 5, 2017, the following parcels in the District are Developed Properties of Land Use Class 1, Residential Property, and for that reason are subject to the levy of the Special Tax for County Fiscal Year 2017-18, as provided in the applicable RMA:




