

- 1 in accordance with applicable provisions of the California Government Code.
- 2 6. In the event the first bidder fails to execute the agreement with the County, the
- 3 County may later award the bid to the runner-up bidder under the same terms as
- 4 stated herein or rebid the agreement. Under such an event, the first bidder
- 5 forfeits the \$1,000.00 deposit and will not be eligible to rebid.
- 6 7. The license will be an exclusive license to operate mobile portable food service
- 7 unit(s), Monday through Friday of each week from 6:00 a.m. to 5:00 p.m., except
- 8 on County observed holidays.
- 9 8. There are three (3) designated locations at the Courthouse Park (Exhibit A).
- 10 9. The license will be for a term of five (5) years commencing on or about January
- 11 1, 2017 and ending December 31, 2021.
- 12 10. The agreement may be terminated immediately for breach of contract and
- 13 without cause upon thirty (30) days written notice given by the County of Fresno.
- 14 11. The Licensee shall pay rent in equal monthly installments due the first day of
- 15 each month and if payment is not made by the 7th of each month, a 10% late
- 16 penalty fee will be charged.
- 17 12. The Licensee, including any and all of the Licensee's officers, agents, and
- 18 employees will at all times be acting and performing as an independent
- 19 contractor.
- 20 13. The agreement may be modified from time to time by written consent of all the
- 21 parties.
- 22 14. The agreement shall be non-assignable without the consent of the County of
- 23 Fresno.
- 24 15. Licensee shall hold the County of Fresno harmless from any costs, damages,
- 25 liabilities, claims and losses to any person or property arising from the use of the
- 26 premises.
- 27 16. Licensee shall maintain Commercial General Liability, Automobile Liability and a
- 28 policy of Worker's Compensation insurance as required.

- 1 17. The Licensee shall, at any time as deemed necessary, make available all of its
2 records and data for audit and inspection by the County of Fresno.
- 3 18. Licensee shall be responsible for trash removal and cleanup.
- 4 19. Licensee shall only sell food and food related products from mobile/portable food
5 service units and no tables, stands or other methods of vending will be allowed.
6 No general merchandise shall be sold other than those items specifically
7 approved by the County of Fresno.
- 8 20. Licensee shall provide food service Monday through Friday, except on County
9 observed holidays and hours mutually agreed upon between both parties.
- 10 21. Venue for any action arising out of or relating to this license agreement shall only
11 be in Fresno County.
- 12 22. All notices between either party shall be in writing and shall be delivered by
13 registered mail.
- 14 23. Electrical power may be available from electrical outlets located in areas
15 designated as 1 and 2 in Courthouse Park.
- 16 24. Licensee shall limit access to food service locations in designated areas 1, 2 and
17 3 (Exhibit A) in Courthouse Park.
- 18 NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors intends to
19 grant the above-described License in accordance with the provisions of this Resolution;
- 20 BE IT FURTHER RESOLVED that bids for the License shall be taken by public
21 auction to be held in the Board of Supervisors' Chambers, Room 301, Hall of Records,
22 2281 Tulare Street, Fresno, California on October 12, 2016 at the hour of 10:00 a.m.
- 23 BE IT FURTHER RESOLVED that notice of the adoption of this resolution and
24 the time and place of opening of bids shall be given by the Clerk to the Board by posting
25 copies of the Resolution signed by the Chairman of the Board in three (3) places in the
26 County of Fresno not less than fifteen (15) days prior to the date of said meeting and by
27 publishing a notice once a week for at least three (3) successive weeks prior to said
28 meeting in the Fresno Business Journal, a newspaper of general circulation printed and




