A MOTION WAS MADE SUPERVISOR MENDES, SECONDED BY SUPERVISOR BRANDAU, THAT THIS MATTER BE ACTED ON AS FOLLOWS: 1) GRANT APPEAL AND OVERTURN THE PLANNING COMMISSION'S DENIAL OF UNCLASSIFIED CONDITIONAL USE PERMIT APPLICATION NO. 3692; 2) ADOPT THE MITIGATED NEGATIVE DECLARATION AND THE MITIGATION MONITORING AND REPORTING PROGRAM PREPARED BASED ON INITIAL STUDY NO. 7948 AND APPROVE THE PROPOSAL SUBJECT TO THE PROPOSED MITIGATION MEASURES AND CONDITIONS OF APPROVAL WITH INCLUSION OF AN ADDITIONAL CONDITION OF APPROVAL THAT APPELLANT INDEMNIFY THE COUNTY FOR ANY LEGAL COSTS; 3) MAKE THE REQUIRED FINDINGS SPECIFIED IN FRESNO COUNTY ZONING ORDINANCE SECTION 873(F) FOR APPROVAL OF UNCLASSIFIED CONDITIONAL USE PERMIT APPLICATION NO. 3692; 4) ADOPT RESOLUTION APPROVING UNCLASSIFIED CONDITIONAL USE PERMIT APPLICATION NO. 3692 TO ALLOW A NEW FUNERAL CHAPEL FACILITY IN CONJUNCTION WITH AN EXISTING CEMETERY (WHICH REFLECTS THE ELIMINATION OF INITIAL STUDY MITIGATION MEASURE NO. 6 AND MODIFICATION TO CONDITION OF APPROVAL NO. 3 DUE TO REVERTING THE POLK AVENUE ACCESS FROM A PUBLIC DRIVEWAY TO EMERGENCY ACCESS ONLY); 5) THE APPLICANT SHALL ENTER INTO AN AGREEMENT INDEMNIFYING THE COUNTY FOR ALL LEGAL COSTS ASSOCIATED WITH ITS APPROVAL OF INITIAL STUDY NO. 7948 AND UNCLASSIFIED CONDITIONAL USE PERMIT NO. 3692 AND PROVIDE SECURITY IN AN AMOUNT DETERMINED BY THE COUNTY FOR ANY SUCH LEGAL COSTS INCURRED. THE AGREEMENT AND PAYMENT OF SECURITY SHALL BE DUE UNLESS THAT LITIGATION PERIOD HAS EXPIRED, IN WHICH CASE THE REQUIREMENTS FOR THE INDEMNIFICATION AND SECURITY SHALL BE CONSIDERED NULL AND VOID; AND 6) DIRECT STAFF TO VERIFY WITH THE NORTH CENTRAL FIRE PROTECTION DISTRICT IF THE POLK AVENUE EMERGENCY ACCESS IS REQUIRED AND IF NOT REQUIRED ELIMINATE THE EMERGENCY ACCESS. SUPERVISOR MAGSIG RECEIVED CALLS ABOUT VENUES NEAR McCALL AND CLINTON AVENUES, ONE OF WHICH IS ADVERTISING TICKETS FOR A CONCERT; REMINDED THOSE WANTING TO USE THEIR PROPERTY FOR SOMETHING OTHER THAN WHAT IT'S ZONED FOR TO OBTAIN PROPER PERMITS; AND, DUE TO THE POTENTIAL SIZE OF THE EVENTS, HAS MADE PUBLIC WORKS AND PLANNING, LAW ENFORCEMENT AND THE CAO AWARE. SUPERVISOR BRANDAU THANKED PUBLIC WORKS AND PLANNING, COUNTY COUNSEL, PUBLIC HEALTH, THE SHERIFF AND THE BOARD FOR WORKING TO RESOLVE ISSUES REGARDING A PROPERTY WITH HEALTH AND SAFETY CONCERNS IN OLD FIG. VICE CHAIRMAN QUINTERO SUGGESTED SUPERVISOR MAGSIG WORK WITH ENVIRONMENTAL HEALTH AS HIS REPORTED ISSUE MAY INVOLVE FOOD PERMITS; THANKED PUBLIC WORKS AND PLANNING, COUNTY COUNSEL AND DEPUTY CAO SONIA DE LA ROSA FOR WORKING TO CLEAN UP NEIGHBORHOOD PROPERTIES; REPORTED THE BIG FRESNO FAIR'S SUCCESSES; AND CONGRATULATED THE RECIPIENTS OF THE MARJAREE MASON CENTER'S SUCCESSFUL "TOP TEN" EVENT. SUPERVISOR MAGSIG ADDITIONALLY REPORTED ON THE AMERICAN RESCUE PLAN ACT (ARPA) AD HOC COMMITTEE'S MEETING LAST THURSDAY: ABOUT \$10 MILLION OF AVAILABLE FUNDS WERE IDENTIFIED; HOW COUNTY DEPARTMENTS, SPECIAL DISTRICTS AND THE COMMUNITY CAN APPLY FOR THESE NON-DISCRETIONARY FUNDS TO MEET ONE OF THE SPENDING CATEGORIES IS BEING EXPLORED; THERE IS A SHORT TIME WINDOW TO DECIDE HOW TO ALLOCATE THESE FUNDS; AND WOULD LIKE THE BOARD'S OPINION ON WHETHER THEY SUPPORT THE PREVIOUS PROCESS OF RECEIVING APPLICATIONS. SUPERVISOR BRANDAU ALSO REPORTED ON THE ARPA AD HOC COMMITTEE MEETING, WHICH CONCERNED UPDATES AND NOT DECISION-MAKING: STAFF REPORTED THAT THE STILL-AVAILABLE FUNDS MAY INCREASE AND WANTED TO USE THE SAME PREVIOUS STRATEGY OF APPROACHING THE PUBLIC AS SOON AS POSSIBLE; UNCHOSEN PROJECTS COULD BE RESUBMITTED; AND COUNTY DEPARTMENTS AND THE COMMUNITY ARE INTERESTED IN SUBMITTING. SUPERVISOR MENDES DISAPPROVED OPENING SUBMISSIONS FOR THESE FUNDS; AND SUGGESTED PUBLIC WORKS AND PLANNING ASSESS COUNTY SERVICE AREAS (CSAs) AND COMMUNITY SERVICE DISTRICTS (CSDs), WHICH REPRESENT UNINCORPORATED COMMUNITIES AND HAVE NOT RECEIVED ARPA FUNDS LIKE THE CITIES. CHAIRMAN PACHECO HIGHLIGHTED \$30 MILLION AS POSSIBLY AVAILABLE; SUGGESTED PREVIOUS APPLICANTS REFRESH THEIR PROPOSALS TO BE MORE ELIGIBLE FOR FUNDS INSTEAD OF POTENTIALLY GIVING NEW APPLICANTS FALSE HOPE; AGREED IT WOULD BE MORE APPROPRIATE TO FUND CSAs AND CSDs, AS THEY ARE THE COUNTY AND BOARD'S DIRECT RESPONSIBILITY, OVER NON-PROFITS WITH OTHER FUNDING OPTIONS; AND MENTIONED THAT THE COUNTY AND CITY OF FRESNO RECEIVED SIMILAR ARPA FUNDS, BUT THE CITY DOES NOT HAVE CSAs NOR CSDs TO CARE FOR. SUPERVISOR BRANDAU CONFIRMED A POTENTIAL \$30 MILLION, BUT CURRENTLY, \$10 MILLION IS AVAILABLE, SOME OF WHICH IS LEFT OVER FROM PRIOR ALLOCATIONS DUE TO PLANNED FUNDING LATER FOUND UNNECESSARY OR FINDING OTHER FUNDING OPTIONS. CAO NERLAND ADDED THAT WHILE THE \$10 MILLION COULD GROW, THERE ARE ALSO ACCEPTED PROPOSALS NEEDING MORE FUNDS. VICE CHAIRMAN QUINTERO ASKED THE CAO TO RETURN WITH AN ESTIMATE FOR FUNDING CSAs AND CSDs. CAO NERLAND REPORTED THAT STAFF IS WORKING WITH PUBLIC WORKS AND PLANNING TO PROVIDE FIGURES. DEPUTY CAO DE LA ROSA DETAILED THAT IF SUBMISSIONS WERE OPENED THIS WEEK, NECESSARY ANALYSES OF PROPOSALS WILL NOT BE COMPLETE BEFORE JANUARY. SUPERVISOR MAGSIG EMPHASIZED NEEDING AN EXPENDITURE PLAN TO AVOID THE COUNTY LOSING ARPA FUNDS. SUPERVISOR MENDES ADVOCATED FOR A SHORT TIMELINE: THE CAO WORKS WITH PUBLIC WORKS AND PLANNING, REPORTS BACK TO THE AD HOC COMMITTEE AND HAS AN AGENDA ITEM FOR FUNDING CSAs AND CSDs AT THE NEXT BOARD MEETING. COUNTY COUNSEL CONFIRMED THE DIRECTION GIVEN TO STAFF
