RESOLUTION

WHEREAS, the Interest and Misc Expenditures Org 2540 requires additional funding to offset the potential future impact of additional Net County Cost associated with the increase in the County's Health Premium Contribution; and

WHEREAS, the funds needed to offset those cost will be funded by a decrease in the Assigned Fund Balance in the General Fund for Capital Projects; and

WHEREAS, said monies are not included in the FY 2016-17 adopted appropriations of the Interest and Misc Expenditures Org 2540; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2016-17 Interest and Misc Expenditures Org 2540 as follows:




