WHEREAS, Public Works & Planning Org 43651500 has accrued savings in FY 2024-25 in Account 7295 (Professional & Specialized Services); and

WHEREAS, said monies will be re-budgeted to FY 2024-25 Adopted Budget for Parks & Grounds Org 7910; and

WHEREAS, Section 29130 of the Governmental Code provides for the re-budgeting of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to decrease the appropriations in the FY 2024-25 Budget for the Public Works and Planning, Org 43651500 as follows:
