SUMMARY OF PROPOSED ORDINANCE

This Ordinance will amend the Fresno County Master Schedule of Fees, Charges, and Recovered Costs of the Ordinance Code of the County of Fresno Section 3800 - General Services, is hereby amended, by adding subsection 3814 relating to the Internal Services Department, Facilities Services Division's (ISD-Facilities Services) fees in the amount of \$65.00 per parking stall per month for recovery of the costs from County departments and other public agencies whose employees are using parking facilities, which are owned or leased by the County, in downtown Fresno.
