Introduction

This Procedural Guide provides details for the 2017-18 Local Assistance for Tree Mortality (LATM) Grant Program authorized by the Legislature in SB 108 and administered by the California Department of Forestry and Fire Protection (CAL FIRE). The 2017-18 LATM Grant Program is a one-time appropriation of \$6 million for grants to local agencies in the 10 high priority counties participating in the Tree Mortality Task Force (TMTF) for the purposes of identifying, removing and disposing of dead and dying trees that pose a threat to public health and safety.

Objective

The objective of the LATM Grant Program is to increase the pace and scale of tree mortality projects by providing up to 25% reimbursement for eligible costs in high priority counties that are 1) consistent with the requirements for tree mortality projects through the California Disaster Assistance Act (CDAA), and 2) consistent with the local CAL FIRE Unit Fire Plan.

Eligibility

Qualifying projects and activities must meet each of the following criteria:

1. Projects conducted within one of the ten high priority counties of Amador, Calaveras, El Dorado, Fresno, Kern, Madera, Mariposa, Placer, Tulare and Tuolumne under the jurisdictional authority of either:
 - a. the governing body (Board of Supervisors or County Administrator) of the high priority county; or
 - b. a CDAA-eligible local agency within the high priority county that has been expressly identified by the governing body (Board of Supervisors or County Administrator) of the high priority county during the application period.
2. Projects consistent with CDAA requirements as administered by the California Office of Emergency Services (Cal OES) for the tree mortality emergency.
3. Projects consistent with the local CAL FIRE Unit Fire Plan.

Funding Allocation and Eligible Costs

The LATM Grant funds will be allocated to the high priority counties as follows:

1. Three million (\$3,000,000) will be allocated equally across the 10 high priority counties (\$300,000 each); and
2. Three million (\$3,000,000) will be allocated across the 10 high priority counties proportional to the estimated number of dead trees in Tier 1 High Hazard Zones (HHZ) on private, state, and local lands (see Table 1) as summarized in the April 2017 publication of [Tree Mortality: Facts and Figures](#).
3. The LATM Grant will provide up to 25% reimbursement for eligible costs approved under the CDAA program up to the below "Total Allocation" dollar amount. Donated Resources included to satisfy the CDAA cost share obligation will be subtracted from reimbursement under the LATM Grant.
4. The governing body (Board of Supervisors or County Administrator) of the high priority county may, at their discretion, provide a portion of their total grant allocation to another CDAA-eligible local agency with jurisdictional authority for hazard tree removal by expressly identifying the local agency and amount of funding to be made available in a signed letter to CAL FIRE during the application process (Appendix I).

Eligible costs include those allowed under CDAA for the tree mortality emergency, including, but not limited to the following:

- Evaluation and identification of dead or dying trees threatening the public rights-of-way and public infrastructure by a certified arborist or forester;
- Removal of trees threatening public rights-of-way and public infrastructure, which may include trees on private property;
- Contracted tree removal, transportation, holding site fees, and disposal; and
- Reasonable Force Account Labor overtime and equipment costs.

Non-eligible costs include those not allowed under CDAA for the tree mortality emergency, including, but not limited to the following:

- Removal of trees from private property that do not pose a threat to public right-of-way or public infrastructure;
- Straight-time Force Account labor;
- Income, fees, revenues, wages, lost or voluntarily waived by a local agency;
- Activities or costs associated with permanent work such the construction of a biomass facility; and
- Deferred Maintenance.
- Costs incurred prior to July 1, 2017.
- Costs exceeding the local agency cost-share obligation under the CDAA.
- Donated Resources of labor, materials, or other valuable considerations provided as part of the local agency's CDAA cost share obligation.

Application Process and Project Administration

The overall application process for the LATM Grant is a three-stage process.

Stage 1- Project Application.

The governing body of each high priority county will be provided a funding advice letter identifying the funding available based on the above allocations and the LATM Grant Application. The county must submit the following documents **no later than February 28, 2018**:

1. Completed CAL FIRE application
2. Copy of Cal OES approved Project Application under the CDAA for the tree mortality emergency;
3. Copy of Cal OES approved tree removal plan
4. Copy of Board Resolution submitted for Cal OES CDAA application.
5. Completed Payee Data Record ([Std. 204](#)).
6. If a high priority county exercises their discretion to do so, a signed letter by the governing body (Board of Supervisors or County Administrator) of that county expressly identifying the local agency and amount of funding to be made available to that local agency.
 - a. Any local agency participating in this grant program shall complete and submit a full application package by the date indicated above.

Stage 2- CAL FIRE Local Unit Fire Plan Consistency Determination

Upon receipt of the application package, CAL FIRE TMTF staff will consult with the local CAL FIRE Unit to determine if the project is consistent with Unit Fire Plan.

Stage 3- Grant Agreement:

No later than April 13, 2018, CAL FIRE will issue an agreement to the local agency along with instructions and requests for any additional documents if needed. Signature on the agreement by the local agency official must be consistent with the designation in the Board Resolution. After the agreement has been fully executed, CAL FIRE will provide the local agency, (now the Grantee) with a signed agreement.

Public Outreach

Public Outreach performed by the Grantee to advertise tree mortality projects conducted under the LATM Grant will be coordinated with the Public Outreach Working Group of the TMTF.

Project Tracking

Grantees shall upload completed projects into the Tree Mortality Mapper no less frequently than monthly for tracking and reporting by the Mapping and Monitoring Working Group of the TMTF.

Payment of Grant Funds

No reimbursement will be provided for work done prior to July 1, 2017. All payments will be made on a reimbursement basis (i.e., the Grantee pays for services, products or supplies, and is reimbursed by the State).

- Grantee shall submit a reimbursement request (Appendix II) to CAL FIRE concurrently with the Cal OES CDAA reimbursement request.
 - 0 The reimbursement request shall include a cover letter identifying project name, project description, appropriate project metrics (acres treated, trees removed, linear miles of road treated), total project cost, and treatment method (Appendix III).
 - 0 For any Damage Survey Report (DSR) including costs incurred both prior to and after July 1, 2017, the Grantee shall clearly delineate those costs that occurred on or after July 1 to receive reimbursement under the LATM.
- Grantee shall notify CAL FIRE of any revisions to the reimbursement request required by Cal OES.
- Cal OES will provide CAL FIRE with an approved DSR for eligible costs and total value of any Donated Resources counted towards the Grantee's CDAA cost-share obligation.
- CAL FIRE will reimburse Grantee up to 25% of the total project costs as determined by Cal OES. Reimbursement amount will be calculated based on total project costs less Cal OES reimbursement and Donated Resources. The total amount shall not exceed the out-of-pocket costs from Grantee.
- CAL FIRE will not provide reimbursement until receipt of an approved DSR from Cal OES.
- Reimbursement by CAL FIRE will occur as frequently as that provided by CDAA (the entire amount is available during the life of the grant program and can be used for partial payments).
- Total reimbursement during the term of the LATM Grant shall not exceed the "Total Allocation" dollar amount identified in Table 1 above.

Interagency Memorandum of Understanding

CAL FIRE will enter into an interagency memorandum of understanding (MOU) with Cal OES for the purposes of administering this grant.

Grant Termination

All project and activity work related to the grant must be completed no later than January 31, 2020. Requests for reimbursement shall be submitted to CAL FIRE and Cal OES no later than February 28, 2020. CAL FIRE shall provide reimbursement for all approved DSRs received through April 30, 2020.
