WHEREAS, the Security Services, Organization (Org) 8970 has the opportunity to purchase three (3) Police Interceptor SUV’s for use in County security services in the current year; and

WHEREAS, Security Services, Org 8970 also has funds available for the purchase of the Police Interceptor SUV’s in the amount of \$111,000; and

WHEREAS, the Fleet Services-Equipment Org 8911 will receive \$111,000 as an Operating Transfer In from Security Services, Org 8970 to purchase the Police Interceptor SUV’s; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues for the FY 2017-18 ISD - Fleet Services Equipment, Org 8911 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote by the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2017-18 ISD - Fleet Services Equipment Org 8911 as follows:




