WHEREAS, the State has identified Help America Vote Act funding to improve polling place accessibility; and

WHEREAS, additional funding is needed to pay travel expenses for accessibility training, and surveying polling places for accessibility, for individuals with disabilities; and

WHEREAS, the State has committed to reimburse counties for staff wages and travel costs incurred to participate in the trainings and for the purchase of accessibility improvement items; and

WHEREAS, said monies are not included in the FY 2017-18 adopted appropriations and estimated revenues of the County Clerk Org 2850; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors.

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2017-18 County Clerk-Elections Org 2850 as follows:


