WHEREAS, the Sheriff-Coroner Organization (Org) 3111 will receive \$28,027.91 plus accrued interest as Operating Transfer In from the Public Facility Fees Fund 1550, Sheriff Patrol & Investigations Subclass 15506 for the purchase of a used vehicle; and

WHEREAS, said monies are not included in the FY 2018-19 appropriations and estimated revenues of the Sheriff Organization 31113229; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2018-19 Sheriff Organization 31113229 as follows:

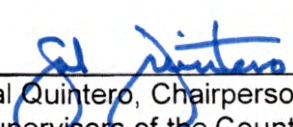
