Resolution

WHEREAS, increased salary and benefit costs have been incurred in the Board of Supervisors Orgs 01100101, Org 01100102, 01100103, 01100104, and 01100105; and

WHEREAS, said Board of Supervisors Orgs require an additional \$100,000 in appropriations in total to pay for those costs; and

WHEREAS, \$100,000, of Unassigned Fund Balance is available in General Fund 0001, Subclass 10000 to fund these expenditures; and

WHEREAS, said monies are not included in the FY 2023-24 adopted appropriations and estimated revenues of said Board of Supervisors Orgs; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2023-24 Board of Supervisors Orgs as follows:
