ORDINANCE NUMBER 26-008

AN ORDINANCE AMENDING THE MASTER SCHEDULE OF FEES, CHARGES AND RECOVERED COSTS FOR COUNTY SERVICES ("MASTER SCHEDULE OF FEES"). THIS ORDINANCE AMENDS SECTION 1000 - COMPUTER SERVICES (EMIS); SUBSECTION 1001; SECTION 1500 -PARKS AND RECREATION, SUBSECTIONS 1501, 1502, AND 1509; SECTION 2200 - PUBLIC WORKS, SUBSECTIONS 2205, 2207, 2208, and 2209.

The Board of Supervisors of the County of Fresno ordains as follows:

Section 1: The Master Schedule of Fees, Charges and Recovered Costs Ordinances is hereby amended as to Section 1000-Computer Services, Section 1500-Parks and Recreation and Section 2200-Public Works. Section 1000 subsection 1001 is updated to read in its entirety as set forth in Exhibit A, attached hereto and incorporated by reference; Section 1500 subsections 1501, 1502, and 1509 is updated to read in its entirety as set forth in Exhibit B, attached hereto and incorporated by reference; and Section 2200 subsections 2205, 2207, 2208, and 2209 are updated to read in their entirety as set forth in Exhibit C, attached hereto and incorporated herein by reference.

Section 2: This ordinance shall take effect and be in force 30 days from adoption.

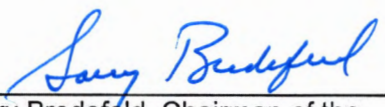

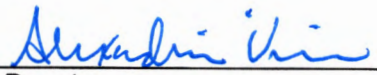
