IN THE MATTER OF DESIGNATING A&J SOCIAL SERVICES )  
LLC D.B.A. SPECIAL SERVICES COMMUNITY CENTER TO )  
CONTINUE PROVIDING DRIVING UNDER THE INFLUENCE ) RESOLUTION  
AND DRUG DIVERSION PROGRAMS SERVICES TO THE )  
COUNTY OF FRESNO )

WHEREAS, on June 20, 2023, the County and Contractor A&J Social Services LLC d.b.a. Special Services Community Center entered into Master Agreement for Driving Under the Influence (DUI) and Drug Diversion Programs (PC1000), which is County agreement number 23-270 (“Agreement”). The purpose of the programs is to reduce the number of repeat DUI offenses by persons who complete a state-licensed DUI program; and provide participants an opportunity to address problems related to the use of alcohol and/or other drugs. Programs consist of Wet Reckless, First Offender (3/6/9 months), 18-Month (second offenders), and 30-month (three plus offenders). First offender participants are assigned based on blood alcohol content (BAC) levels. Existing law specifies the court procedures for treatment of certain drug offenders to PC 1000 programs instead of prosecution.

WHEREAS, DUI programs are licensed by the California Department of Health Care Services (DHCS) and regulated by Title 9 of the California Code of Regulations (CCR). Pursuant to Title 9, Section 9805, a county board of supervisors' resolution or minute order recommending licensure, including a statement from the board indicating there is a demonstrated need for a new DUI program and the establishment of an additional program will not jeopardize the fiscal integrity of existing licensed DUI programs is required to accompany a DUI program license application to DHCS.

WHEREAS, A&J Social Services LLC d.b.a. Special Services Community Center, is currently a contractor on Agreement 23-270 and is undergoing a transfer of ownership. As such,

1 DHCS requires the program to reaffirm the Board of Supervisors is in support of continuing the  
2 partnership with A&J Social Services LLC d.b.a. Special Services Community Center before a  
3 new license will be issued.

4        WHEREAS, recommending licensure for A&J Social Services LLC d.b.a. Special  
5 Services Community Center will not adversely impact the current service levels for the County  
6 of Fresno. A&J Social Services LLC d.b.a. Special Services Community Center currently has  
7 four (4) separate locations across the County of Fresno: Clovis, Kerman, Reedley, and Selma.  
8 Each location provides services to no less than 200 participants a year. A&J Social Services  
9 LLC d.b.a. Special Services Community Center will continue to provide these same services  
10 under new ownership if licensure is approved by DHCS.

11        WHEREAS, denying the recommendation will put a strain on the remaining programs  
12 and leave portions of the County with reduced program support. The loss of these locations may  
13 cause an undue burden on the participants necessitating greater costs to the participants in  
14 transportation, time, and financial repercussions. These challenges can result in a decline in  
15 participation in the DUI and PC1000 diversion programs.

16        NOW, THEREFORE, BE IT RESOLVED, that the Fresno County Board of Supervisors  
17 hereby recommends licensure for A&J Social Services LLC d.b.a. Special Services Community  
18 Center to continue providing DUI and PC1000 diversion services to the County of Fresno.


