BETWEEN KINGS CANYON ROAD AND )  
BUTLER AVENUE )

WHEREAS, the Director of the Department of Public Works and Planning, on the basis of a traffic engineering study, has recommended that NO PARKING signs be installed on DeWitt Avenue between Kings Canyon Road and Butler Avenue, because the signs are necessary to properly indicate and carry out the provisions of the Vehicle Code, necessary to guide traffic, and necessary to prevent motorists from obstructing traffic.


NOW, THEREFORE, BE IT RESOLVED that the Fresno County Board of Supervisors does authorize the installation of NO PARKING signs on DeWitt Avenue between Kings Canyon Road and Butler Avenue, to properly indicate and carry out the provisions of the Vehicle Code, to guide traffic, and to prohibit motorists from parking vehicles upon a highway, which impedes or obstructs the normal and reasonable movement of traffic, unless the stop is necessary for safe operation or in compliance with law.

Now, THEREFORE, BE IT FURTHER RESOLVED that the Fresno County Board of Supervisors directs the Director of Public Works and Planning to erect NO PARKING signs in a manner not inconsistent with this resolution.
