10 WHEREAS, the Fresno County through the Sheriff's Office desires to undertake a certain project
11 designated as ABC Alcohol Policing Partnership (APP) program grant project to be funded in part from
12 funds made available through the APP administered by the Department of Alcoholic Beverage Control
13 (hereafter referred to as ABC);

14 NOW, THEREFORE BE IT RESOLVED that the Sheriff's, or her/his designee's, previous
15 submittal of the grant application in relation to the ABC APP is retroactively approved and authorized and
16 any and all related actions by the Sheriff, or her/his designee, are hereby approved and ratified;

17 NOW, THEREFORE BE IT RESOLVED that the Chairman of the Fresno County Board of
18 Supervisors is authorized to execute on behalf of the Fresno County Board of Supervisors the attached
19 retroactive contract, including any extensions or amendments thereof and any subsequent contract with
20 the State in relation thereto;

21 IT IS AGREED that any liability arising out of the performance of this contract, including civil
22 court actions for damages, shall be the responsibility of the grant recipient and the authorizing agency.
23 The State of California and ABC disclaim responsibility for any such liability;

24 BE IT FURTHER RESOLVED that the grant funds received hereunder shall not be used to
25 supplant expenditures controlled by this body.


26 IT IS ALSO AGREED that this award is not subject to local hiring freezes.


