WHEREAS, the Fresno County Public Library Org 7511 requires \$321,000 to meet expenditures associated with the purchase of furniture items for Selma branch; and

WHEREAS, the Library Organization 7511 has sufficient estimated revenues to fund the costs associated with capital asset purchase modular circulation desk and other furniture library book shelving for adult and children’s area; and

WHEREAS, said monies are not included in the FY 2024-25 recommended appropriations of the Library Organization; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths (4/5) vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase FY 2024-25 Library Organization 75110800 as follows:


