

NOTICE is hereby given that at its regularly scheduled meeting on March 24, 2020, the Fresno County Board of Supervisors adopted Ordinance No. 20-005, an Ordinance of the County of Fresno, State of California

SUMMARY OF ORDINANCE

The Ordinance to amend Section 4.04.025 of Chapter 4.04 of the Ordinance Code of Fresno County, and renaming Section 4.04.025 "Lease or License of Any Real Property for Use by County." This Ordinance authorizes the County Administrative Officer or Director of Internal Services/Chief Information Officer to negotiate and execute in the name of the County, as lessee, all leases and licenses of real property with private entities or governmental agencies which the County may require, subject to the provisions prescribed in Government Code section 25350.51. Notice of the County's intention to consummate the lease or license must be posted at the Hall of Records, Plaza Building and the site of the lease for five working days, as required by Government Code Section 25350.51, prior to approving and executing the lease or license. The notice shall describe the property proposed to be leased or licensed, the terms of the lease or license, and any County officer authorized to execute the lease or license.
