RESOLUTION

WHEREAS, the County of Fresno, PeopleSoft Operations Org 8933 requires an increase in appropriations in the amount of \$250,000 to allow for the payment of technology related systems needed to meet the standards of a fully functional mobile workforce to address departmental emergency protective measures and operational changes in response to the Novel Coronavirus (COVID-19); and

WHEREAS, said additional costs will be financed by revenue from available public assistance funds provided through the Coronavirus Aid, Relief, and Economic Security (CARES) Act in the amount of \$250,000; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues for the FY 2020-21 PeopleSoft Operations Org 8933 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote by the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in FY 2020-21 PeopleSoft Operations, Org 8933 as follows:


