WHEREAS, the Medi-Cal – HHIP & IPP Org 0129 requires \$161,453 to meet
expenditures; and

WHEREAS, the Medi-Cal – HHIP & IPP Org 0129 requires appropriations to fund an
Operating Transfer Out in the amount of \$161,453 to the Office of Housing and Homelessness
Org 5428; and

WHEREAS, sufficient funding is available through the Agreements with the Managed Care
Plans for Medi-Cal Grants in the amount of \$161,453; and

WHEREAS, said monies are not included in the FY 2026-27 adopted appropriations and
estimated revenues for Medi-Cal – HHIP & IPP Org 0129; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of
these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector
is authorized to establish appropriations in the FY 2026-27 Medi-Cal – HHIP & IPP Org 0129 as
follows:

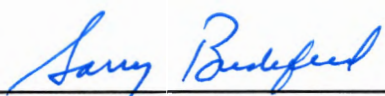

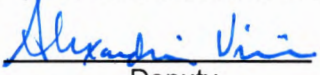
