WHEREAS, the Fresno County Planning Commission, on June 26, 2018 held a duly noticed public hearing and considered General Plan Amendment (GPA) Application No. 552 and its associated Rezone Application No. AA 3825; and

WHEREAS, at the conclusion of the public hearing, the Fresno County Planning Commission recommended approval of GPA No. 552 and Rezone No. 3825; and

WHEREAS, the Board duly fixed September 11, 2018, for a public hearing on the amendment of the County General Plan and the public hearing was held thereon in the manner prescribed by law; and

WHEREAS, the Board considered the Agenda Item with attachments including the Planning Commission Staff Report, the proposed amendment, and the Planning Commission's resolution; and

WHEREAS, the Board heard and considered verbal and/or written public testimony on the proposed amendment; and

WHEREAS, the amendment of the General Plan consists of re-designating the land use of two adjacent parcels totaling 4.15 acres from Rural Density Residential to Limited Industrial to allow an animal hospital/shelter and related uses; and

WHEREAS, on the basis of the whole record before the Board of Supervisors, including any comments received, there is no substantial evidence that this amendment to the General Plan will have a significant effect on the environment; and

WHEREAS, this will be the first amendment cycle to the Fresno County General Plan in this calendar year.

1 NOW, THEREFORE IT IS HEREBY RESOLVED that the Fresno County Board of Supervisors
2 hereby adopts Resolution amending the Fresno County General Plan as proposed by GPA No. 552.
