WHEREAS, the Library-Measure B Organization 7511 has the opportunity to update the exterior with a vehicle wrap design on a Winnebago to advertise and market the Digibus Mobile Classroom in the current year; and

WHEREAS, the Fleet Services Organization 8910, requires an increase in appropriations in the amount of \$19,000 to allow for the payment of costs related to the installation of the vehicle wrap; and

WHEREAS, the Library has funds available to fund the vehicle wrap design on a Winnebago in the amount of \$19,000; and

WHEREAS, said monies are not included in the adopted appropriations and estimated revenues for the FY 2016-17 Fleet Services Organization 8910 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote by the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2016-17 Fleet Services Organization 8910 as follows:
