WHEREAS, said monies are not included in the FY 2025-26 appropriations and estimated revenues of the Library Book Fund Organization 7521; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2025-26 Library Book Fund Organization 7521 as follows:
