IN THE AMOUNT OF \$31,500)

WHEREAS, the Sheriff’s Federal Asset Forfeiture Treasury Organization 1466 requires \$14,000 to meet expenditures associated with the costs to purchase the canine; and

WHEREAS, \$14,000 is available in the fund balance of the Sheriff-Coroner Special Revenue Fund 0095, Subclass 17665 to fund these expenditures; and

WHEREAS, said monies are not included in the FY 2021-22 adopted appropriations and estimated revenues of the Federal Asset Forfeiture Treasury Org 1466; and

WHEREAS, the Inmate Welfare Fund Org 1500 requires \$17,500 to purchase the canine for the Drug Enforcement Unit; and

WHEREAS, \$17,500 is available in the fund balance of the Special Revenue Sheriff Fund 0096, Subclass 17700, Sheriff-Coroner Org 1500 to fund these expenditures; and

WHEREAS, said monies were not included in the FY 2021-22 adopted appropriations of the Sheriff-Coroner Org 1500; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2020-21 Sheriff-Coroner-Public Administrator Organization 3111 as follows:
