WHEREAS, the County of Fresno will receive \$721,672 from the Aid to Families with
 Dependent Children-Foster Care to cover administrative costs related to Intensive Service Foster
 Care; and

WHEREAS, said monies are not included in the FY 2018-19 adopted appropriations and
 estimated revenues of the Intensive Services Foster Care Organization 1131; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of
 these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector
 is authorized to increase the appropriations in the FY 2018-19 Intensive Services Foster Care
 Organization 1131 as follows:


