WHEREAS, the County of Fresno will receive \$70,000 from the sale of surplus vehicles;

and

WHEREAS, \$165,000 of Federal Inmate revenue is available in the General Fund 0001 to fund the purchase of Sheriff's Vehicles; and

WHEREAS, said monies are not included in the FY 2020-21 adopted appropriations and estimated revenues of the Sheriff-Coroner-Public Administrator ORG 31113229; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2020-21 Sheriff-Coroner-Public Administrator ORG 31113229 as follows:


