WHEREAS, the Probation Org 34409999 requires \$20,037 to pay for one TekNET and body scanner software, that were approved for purchase under Agreement No. A-25-196; and

WHEREAS, \$20,037 is available in the fund balance of the Juvenile Facility Grant Fund 0075, Subclass 17306, Org 1146; and

WHEREAS, Probation Org 34409999 will receive funds as an Operating Transfer In from the Juvenile Grant Fund Org 1146; and

WHEREAS, said monies are not included in the FY 2025-26 adopted appropriations and estimated revenues of the Probation Org 34409999; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2025-26 Probation Org 34409999 as follows:
